1 COMMONWEALTH

1.1 Guide to the Commonwealth Legislation Review schedule

The Commonwealth Legislation Review Schedule arises out of the requirements of the Competition Principles Agreement (CPA), under which the Commonwealth, State and Territory Governments agreed to review, and where appropriate, reform all legislation that restricts competition by the year 2000.

The Commonwealth uses a regulation impact statement (RIS) framework to analyse legislation. The process incorporates an analysis of regulatory restrictions on competition, but also analyses the costs and benefits that legislation imposes on business.

The use of the RIS framework provides a consistent, systematic and transparent process for assessing alternative approaches to problems which may require Government action. The framework requires: identification of a problem or issue; identification of an objective; options for achieving the objective; assessment of costs and benefits (including compliance burden and small business issues); a recommendation; and a strategy to implement and review the preferred option.

Progress to 31 March 1998

Twenty-eight reviews were scheduled to commence in 1997-98. At 31 March 1998, fifteen had commenced, of which one had been completed. The Wool International Act 1993 was deleted from the schedule, seven reviews were deferred and the remaining five reviews were still to commence. Of reviews commenced but not finalised in 1996-97, ten were still underway and two were completed in 1997-98.
