6.1 Guide to the South Australian legislation review schedule

[The following information draws on the *Report to the National Competition Council Implementation of National Competition Policy and Related Reforms in South Australia, April 1998;* and correspondence dated May and July 1998.]

Highlights

- 35 reviews completed by May 1998
- review timetable updated
- guidelines distributed to agencies
- potential joint reviews identified

Updating of timetable

In May 1998, the Government published an updated version of its original June 1996 timetable for review. The revised version took account of:

- changes to the timing of the reviews;
- redesignation of some potential national reviews as State reviews; and

• addition of four pieces of legislation passed between April 1995 and March 1997 which contained non-trivial restrictions on competition that had not been subject to a public interest test.

Reviews completed by May 1998

The May 1998 update of the legislative review timetable lists 178 Acts for review. Of these, 33 were reviewed in 1997. A further 11 are to be scheduled for review after it is determined whether they should be reviewed jointly with other States or Territories, nationally, or on a State basis. One Act, the *Biological Control Act 1986*, has been removed from the timetable because it contains no restrictions on competition. The other Acts on the timetable are scheduled for review between 1998 and 2000.

Several significant reviews were completed during 1997, including of the *Cooper Basin (Ratification) Act 1975, Barley Marketing Act 1993*, and the *Casino Act 1997*.

Guidelines for Agencies

To help agencies complete National Competition Policy reviews, the Crown Solicitor's Office in conjunction with the Department of the Premier and Cabinet, prepared and distributed review guidelines in February 1998. The Guidelines are also useful more generally for review of regulation.

An implementation plan has been adopted by all agencies conducting legislation reviews. This provides for the formation of a Reference Group to provide for effective consultation on all aspects of National Competition Policy implementation in South Australia, training of officers conducting reviews, development of strategies for completion of reviews by scheduled dates, quarterly monitoring of progress and techniques for reducing the time and resources required to complete reviews.

Identification of possible national reviews

National reviews may be a more efficient use of resources and produce more consistent outcomes than State and Territory based reviews. All jurisdictions are considering proposals to group together within joint reviews: 11 Acts governing professional occupations; three Acts governing gambling; two trade licensing Acts; and three Acts concerning real estate occupation
