6.1 Guide to the South Australian legislation review schedule

Legislation review

South Australia's legislation review timetable was most recently updated in May 1998. There have been several changes to both content and timing of reviews - the timetable currently lists 179 separate pieces of legislation for review.

To help agencies complete National Competition Policy reviews, and regulation reviews generally, the Crown Solicitor's Office in conjunction with the Department of the Premier and Cabinet, prepared and distributed the *Guidelines Paper for Agencies conducting a Legislation Review under the CoAG Competition Policy Agreement* in February 1998.

Agencies conducting legislation reviews adopt a process involving a Reference Group to provide for effective consultation on all aspects of NCP implementation in South Australia. The Reference Group is also responsible for the training of officers conducting reviews, development of strategies for completion of reviews by scheduled dates, quarterly monitoring of progress and techniques for reducing the time and resources required to complete reviews.

Progress to 31 December 1998

South Australia had scheduled 121 reviews for completion by the end of 1998. South Australia's tabulations in its annual NCP report indicated that 46 reviews were complete, including five reviews that had originally been scheduled for 1999 or beyond.

The Government had announced its response to 27 reviews. In 21 cases, the Government repealed legislation, or identified legislation for repeal once it was no longer operational. Acts repealed to date include the *Bulk Handling of Grain Act 1955*, *Catchment Water Management Act 1995*, *Manufacturing Industries Protection Act 1937* and *The Carriers Act 1891*. Proclamation of the *Livestock Act 1997* streamlined regulations affecting market entry and conduct relating to the keeping of bees, cattle, pigs and deer by repealing six separate Acts. The Government was drafting new legislation following the review of the *Local Government Act 1934*.

Some 73 reviews scheduled for completion by the end of 1998 were still underway. South Australia's report indicated that 22 of these were expected to be completed in 1999, with a further two expected to become national reviews.

Of the 13 reviews scheduled for completion but not yet commenced, three are to be examined through a national process. Review of the *Occupational Health, Safety and Welfare Act 1986* was deferred so that it could be examined in conjunction with related legislation in 1999. South Australia advised that the remaining 1998 reviews not commenced will be reviewed during 1999.
